**RE: NATIONAL COMMUNITY PHARMACISTS ASSOCIATION SUPPORT OF HB 1404**

Dear Representative Weber and Representative Campion,

I am writing to you today on behalf of National Community Pharmacists Association in support of HB 1404. This legislation would increase patient access to human immunodeficiency virus (HIV) pre-exposure (PrEP) medications and result in HIV related cost savings while combating the spread of the virus.

NCPA represents the interest of America's community pharmacists, including the owners of more than 21,700 independent community pharmacies across the United States and 33 independent community pharmacies in New Hampshire. These New Hampshire pharmacies filled over 1.9 million prescriptions last year, impacting the lives of thousands of patients in your state.

Ninety-one percent (91%) of Americans live within five miles of a community pharmacy.<sup>1</sup> More than any other segment of the pharmacy industry, independent community pharmacists are often located in the underserved rural and urban areas and are frequently the most accessible healthcare providers in many communities and are critical for the provision of immunizations and other preventive care services in the community. In addition community pharmacists are proud to play a vital role in the New Hampshire's efforts to increase access to PrEP medications statewide. Access to pharmacy care services and HIV PrEP medications will play a critical role in combating the HIV epidemic and staving off costly downstream medical interventions.

Like other medical professions, the pharmacy profession has evolved from a dispensing and product reimbursement based industry to a profession with the *training* and patient *relationships* to provide outcomes-based services and participate in care coordination efforts.<sup>2</sup> Although we are appreciative of this legislation, to ensure patient safety, we recommend including language that would require a pharmacist training program for PrEP medications and services. The training program will aim to address the challenges and knowledge gaps, not limited to, counseling unique populations, recommending appropriate vaccinations, understanding HIV disease state, HIV medications along with how and when to exercise appropriate patient follow-up, refer the patient to necessary resources and healthcare providers.

Such a training program will optimize efforts in supporting all facets of the patient's experience relating to PrEP services and ensure a high standard of care in carrying out the responsibilities aligned with lowering the rates of HIV infection throughout the state.
